CMS Issues FY 2017 Medicare **IPPS Correction Notice**

The Centers for Medicare & Medicaid Services has issued a correction notice to the Hospital Inpatient Prospective Payment System for fiscal year 2017. The changes are effective as of Oct. 1, 2016.

The 47-Page display copy is at https://www.federalregister.gov/d/2016-24042. Publication in the Federal Register is scheduled for Oct. 5.

Most changes are minimal in nature, but many do impact the final payment amounts.

Capital

The capital standard federal payment rate—FY 2017 is corrected from \$446.81 to \$446.79, a difference of \$-.02.

Outliers

The outlier threshold is corrected from \$23,570 to \$23,573.
