

## Facility-Specific Reports for OP-32

The Centers for Medicare & Medicaid Services has released facility-specific reports (FSR) for the Facility Risk-Standardized Hospital Visits within Seven Days after Outpatient Colonoscopy measure (OP-32) for Hospital Outpatient Departments. These reports contain the calendar year 2016 performance period measure results for public reporting in December 2017, which will affect 2018 payment determination.

The FSR based on the full 2016 performance period (January 1 – December 31, 2016) is the culmination of prior claims-detail reports provided to facilities in September 2016, December 2016 and March 2017. The FSR contains the full 2016 calendar year of patient-level data, as well as facility-specific risk-standardized rate results, and state and national results for the colonoscopy measure. CMS encourages facilities to review their FSRs and accompanying User Guide thoroughly.

### Accessing Your Facility-Specific Report

Facilities do not need to request FSRs; FSRs are available through the *QualityNet* Secure Portal. Registered users should be able to access their accounts and FSRs by logging into the Portal, and clicking *Secure File Transfer* from the top right corner of the screen. From here, users can view their mailbox and select *Inbox* to access their facility's FSRs during the October 2017 preview period. Facility staff currently assigned the designated roles ("File Exchange & Search" role and "View QNet Content" role) will have access to their FSRs in their *QualityNet* Secure File Transfer Inbox. ### Other Notes

- The FSRs to be delivered in October 2017 are different from the CDRs provided in September 2017:
  - The October 2017 FSR will contain information from CY 2016, will be used for public reporting in December 2017, and will affect payment determination in CY 2018
  - The September 2017 CDR contains information from January - May 2017 and includes cases to be used in the calculations for payment determination in CY 2019.
- A facility will not receive an FSR if:
  - It was not open during the time period in which the measure was calculated (January 1, 2016 through December 31, 2016);
  - There were no eligible cases for the calculation of the measure during the measure timeframe; or

- A facility did not have a *QualityNet* Secure Portal user account with the appropriate designated roles.
- All facilities may access a “mock” FSR on the *QualityNet* website by visiting

The mock FSR contains actual national-level results and simulated facility and state-level data.
