NOTICE OF HEARING, NOTICE TO INTERESTED PERSONS, AND ORDER

IT IS ORDERED that a public hearing pursuant to § 382.060 RSMo (Supp. 2015) regarding the Form A proposed acquisition filed by Anthem, Inc. to acquire Cigna Dental Health of Missouri, Inc. and Cigna Healthcare of St. Louis, Inc. ("Cigna") is scheduled for:

Such hearing shall continue on November 18, 2016, as needed, without further written order.

IT IS ORDERED that Anthem shall provide Cigna at least seven (7) days prior notice of this hearing.

THE FOLLOWING PROCEDURES ARE ORDERED to maintain order of the hearing, insure the development of a clear and complete record, to allow all interested persons the opportunity to participate, and to accommodate the opportunity for Anthem, Cigna, and the Division of Insurance Company Regulation (hereafter “the parties”) for cross examination or rebuttal:

1. Any person to whom notice of hearing was sent and any other persons whose interests may be affected by the proposed acquisition (hereafter, “interested persons”) may provide oral or written submissions regarding Anthem’s proposed acquisition of Cigna as set forth in the below.
2. Any interested person who intends to actively participate at the hearing shall file a written entry of appearance in accordance with 20 CSR 800-3.020(6) **on or before 5:00 p.m., CST, November 10, 2016** as set forth below. In accordance with 20 CSR 800-3.020(6), a corporation, association or other entity shall be represented by an attorney.
3. Any interested person who intends to actively participate in this matter shall file written notification with the Hearing Officer **on or before 5:00 p.m., CST, November 10, 2016** and indicate their intent to participate as to each of the following:
 - (1) Present evidence;
 - (2) Examine and cross-examine witnesses;
 - (3) Offer oral argument; and/or
 - (4) Offer written argument.

7. If the parties wish to file a response to any written comments, such response(s), in hard copy, **must be filed with the Hearing Officer no later than 5:00 p.m., CST, Wednesday, November 30, 2016.**

Any interested person who files a notification of participation will be offered the opportunity during the hearing to present evidence, examine and cross-examine witnesses, and offer oral argument or written argument. In addition, if an interested person presents oral testimony under oath during the hearing, the witness must attend the hearing in person and may be subject to cross-examination by the parties or other interested persons. Oral or written comments, not under oath, will not be subject to cross-examination.
