By subscribing to **HIDI's 2017 Premier Reporting Package** and the **2017 Premier Data Package**, your hospital will have access to an assortment of HIDI's most popular data products **at a bundled price**. Packages are available to hospitals participating in the HIDI discharge data submission program.

## PREMIER PACKAGE BASICS

- HIDI Analytic Advantage<sup>®</sup> folders will be populated with data and/or reports throughout the year as the data become available. The tables on the following pages outline the anticipated distribution date(s). Data and/or reports will remain in the premier folders until the package expiration on Dec. 31, 2017.
- Data will be removed from the premier folder(s) at the end of the subscription period to prepare for the inclusion of content associated with the following year's subscription.
- Staff from hospitals who do not renew their subscriptions to the premier packages for subsequent years will have premier access removed before the next subscription period.
- The subscription dates will remain January to December, regardless of the month that a member chooses to subscribe.
- Subscribers will have access to complete contents of the package, regardless of the month that a member chooses to subscribe.
- Package pricing will not be adjusted for late subscribers.
- Some Premier Reporting content is now available as interactive reports, accessible on Analytic Advantage<sup>®</sup> PLUS.
